B. Language Proficiency

Applicants must provide one of the following as proof of language proficiency.

1) Korean Proficiency : Applicants with TOPIK Grade 3 or above or with KIT TOPIK Grade 3 at the Korean Language Course in Kumoh National Institute of Technology.

***** Once admitted, students are recommended attain TOPIK Grade 4 or above before graduation.

2) English Proficiency: Applicants should have one of the follwing officially recognized English Proficiency Test scores; TOEFL : PBT 550, CBT 210, iBT 80, IELTS:5.5, TEPS: 550 or higher.

7. Reminders

1) Additional Information

a) All documents should be in Korean or English. Documents in another language should be accompanied by a notarized Korean or English translation.

b) Original documents should be submitted. Should they be unavailable, however, copies must be authorized by the originating institution before they are submitted.

c) Admitted students who are expected to graduate from Secondary School (High School) must submit their graduation no later than the 1st day of semester.

d) If any of the application documents contain false information or forgery, admission will be cancelled immediately.

e) All documents will not be returned.

f) If necessary, additional documents might be needed.

2) Other guidelines

a) Admission will be cancelled in case tuition is not paid during the designated period.

- b) Applicant must write down exact mailing address and telephone number.
 - Communication cut off is applicant's own responsibility.
 - Applicant must directly leave new contact number in case of any change.

c) Announcement of acceptance will be released on the kit webpage and applicant will not be informed individually.

d) Any unexpected notices will be informed on kit webpage and applicant will not be informed individually.

e) Items not mentioned above will be decided by the committee of Admission Screening

f) If an applicant's visa is not issued or is rejected, his or her application will be cancelled.

h) Successful candidate MUST submit the certificate of medical insurance within 30 days from the beginning of the semester.
